When talking to Michael, his report was not as it first seemed as he stated that his neighbours were not at fault as they have only heard this information Michael explained that particularly dislikes him and has over time made housing association aware that he is not a good tenant. Despite this, these rumours appear to be an isolated incident and as agreed with Michael it seems as though words of advice are most appropriate on this occasion to dissuade from stirring gossip and parking in front of Michael's vehicle.
