The detained person was reminded of the reasons for their continued detention in that; Incedent Assault on Female under 14 The DP appeared sober and healthy they have no representations Having looked into the circumstances and spoken with the custody sergeant and I am satisfied that enquiries are being conducted diligently and expeditiously. I am satisfied there is insufficient evidence to charge at this time. As interview is required The DP is legally represented by Christian BridgeThey have not been given the opportunity make representations on behalf of the detained person as shortly attending for interview. The DP does require an appropriate adult. Further detention is authorised and necessary in order to secure evidence and/or obtain evidence by way of questioning. The person's comments on being informed of the review decision were None made. The OIC did inform the authorising officer of any documents or materials in their possession or control which appear to undermine the need to keep the suspect in custody. The documents and materials were not made available to the detainee or their solicitor.
