		<p>Mr Burdette Deakin 22 Shrub House Close Beck Row Bury St Edmunds Suffolk IP28 8AN</p> <p>12/08/2020</p> <p>Re: ANTI-SOCIAL BEHAVIOUR</p> <p>Dear Mr Burdette Deakin</p> <p>We are writing to you about your recent conduct towards our staff, we note this is not the first time we have had to write to you regarding these issues and it's not something we are willing to tolerate.</p> <p>An issue was reported regarding yourself having bonfires and smoking cannabis in your property, since we made you aware of the complaints we are receiving, you have continually emailed Pete Sharples multiple times in a day using unacceptable language. At the peak, these emails are being sent hourly by yourself to Pete.</p> <p>We understand this is frustrating and you have claimed that the cannabis is for medicinal use, however we have a duty to investigate any behaviour complaints that are received and will continue to do so until the problem is resolved.</p> <p>We will not tolerate, under any circumstance, abuse, aggression or threatening behaviour towards members of our staff or contractors. You are currently not permitted to attend any of Flagships Offices in person, and if the behaviour continues by email, we will have no option but to restrict the communication we have with yourself in the future by this means also.</p> <p>Should you engage in any further anti-social behaviour towards our staff, in breach of your tenancy, then we shall consider taking formal tenancy action against you, which may result in possession proceedings. This letter, along with the previous letter sent to you regarding your conduct will remain on your house file.</p> <p>As you have been advised in the past, if you wish to raise any tenancy queries or make contact with a member of staff at Flagship you must do so over the telephone via our Response centre. We would also like to make you aware that abusive or threatening behaviour will not be tolerated over the telephone, likewise it will not be tolerated by email.</p> <p>After this letter was sent there was a further 58 emails sent to Pete Sharples. Some of the examples of content are: 'you are going to unemployed and homeless you cunt by the time i've finished with you. How do you like your liver Pete? chopped or stewed? i'm going to destroy you.</p>

He has given a partial admission to the offence. In the interview he stated that this issue has been going on for longer than it being reported to us, he also stated that there were more emails

		<p>that have been sent to the amount that was put forward to him in the interview.</p> <p>All the questions had been put forward to him, he also confirmed that his email address was the one that was used in the offence and that it has not been hacked by any other party. He also stated that if police tried to access his phone or computer that was seized the phone and the computer would kill its self as he has downloaded a software that would kill the phone. In the interview he got angry when was asked some questions, when he got angry he shouted "I'm emailing him in a work capacity" he also stated "all I've done is send emails to his work email address".</p>
