I have been trying to assess how the incident of 27/09/2020, and indeed its very beginnings during the late evening of 23<sup>rd</sup> September 2017, has impacted my life but I am finding that impact too huge to put into the proper context.

Having my computer and other electronic equipment seized speaks really of only one thing to friends and the general public alike, child pornography.

I have a very 'public' persona and character.

Given that the police were sent malicious communications regarding my character by an individual in a position of authority with enhanced trust, a high duty of care and very high credibility with the police such that the impact of that malicious denigration of my character is immense.

To my knowledge this maliciousness began in September 2017 and still persists among my neighbours and with the general public in the county I live in.

I am very well known it is very hard to miss someone driving through town in an open convertible with a bright green parrot sitting on their shoulder, it gets more amazing when you learn the parrot is free flying, is not 'wing clipped' or harnessed.;

This alone brings greater impact and consequences from the malice that continues to be promulgated by a number of individuals including the instigator of that arrest on 27th September 2020.

The highest form of respect is when someone attempts to emulate what you do, the internet has examples of the same thing, I AM the singular individual of that 'breed' that does it in a convertible with the roof down... With a free flying, unharnessed bird.

My support animal helps me manage my social anxiety, my PTSD and is an excellent 'ice breaker' who keeps me 'grounded' and less likely to experience panic attacks.

I have trained three support animals to date, it takes a huge amount of time, time that is now lost.

I can no longer depend on my support companion for the mental stability I once had, I can no longer enjoy the security I once had, the attentive care I gave her while out ensuring she was relaxed and comfortable among people and traffic kept me at a lower state of social anxiety driven agoraphobia.

Three individuals are the source of the police involvement born purely of jealousy and narcissistic

sociopathy, those that cannot have or cannot compete tend to determine it must be destroyed.

My life as it was is over, I can no longer raise a smile on the faces of the people and children I meet while out because they are amazed at my companion animal and her loyalty, because I start to 'break' inside at the injustice and have to walk away. So, I almost never take my support animal with me now, she suffers too....

My life has been destroyed by one man with a guilty conscience and a woman who even now persists in denigrating my character and person with repeated malicious hate speech to all and sundry high and low including the police who seem incapable of distinguishing between two entirely different individuals from their own records.

The malice generated causes me to no longer feel safe outside my home.

I still am approached by individuals or groups asking me if I am the individual chased out of Red Lodge for alleged paedophile type behaviour.

I do not feel my life is worth living

Purely because the police accepted on word alone the credibility of a man in a position of enhanced trust with high credibility and duty of care in the community who was behaving with anything but the moral and ethical standard expected of the position.

I do not know how to pick up my life from this, clearly from the body worn camera on the evening of 27th September 2020 the police were of the mind I was that individual indicated in the email between Sharples and Benton which was sent AFTER that incident on 27th September 2020.

The police by that stage should have been very well aware that the individual indicated in the email and myself are in fact two entirely different people.

Why was Sharples not arrested and charged with that malicious communication the moment it was received by police Sgt 1845 Benton?

There is seriously something wrong there, was it Sharples credibility and manipulation of the police that allowed that criminal email to 'pass' inspection?

I am devastated, I feel my life is LESS than worthless.

Some very serious failures with the police integrity have caused this.

I liken it to killing a blind person's guide dog and leaving them helpless in the street, it is devastating.

Mr Sharples instigated the incident of 12th May 2021 which resulted in my misdiagnosis by Dr C Zapata who states on his report I was "**paranoid and delusional, abused by his landlord**"

This misdiagnosis remains on my medical record in spite of demonstrating to an appeal panel six days into a 28 day Section under MHA2 that the abuse was in fact real and true. I was released immediately and driven home.

I cannot even begin to describe the impact of all this; I am in a prison. That prison is my own home.
