Dear All,

I've just returned from a week annual leave and I am surprised and concerned that this man has been discharged already after less than a week!

He had a 60 gram delivery (gets this amount every month) from his medical cannabis clinic already delivered prior to his recent section 136 and ward admission. He had some of this cannabis when he was admitted under section 2 and the rest was at his home so he would still have access to this unless it was removed when his pets were placed into care?

I'm concerned that he had his so called medical cannabis returned to him when he was discharged; I had already documented into Lorenzo my contact with his Harley street drs and they had agreed that they would no longer prescribe/dispense cannabis as they were also concerned (once I advised them) regarding his paranoid presentation. Therefore this cannabis was no longer medically prescribed and at that point it should be considered deleterious to his health, which in my view was the case all along.
