Hi Karl ,

Ive had a further conversation with my Line Manager and to expand on the original reasons stated for requesting this information its around staff and tenant safety .

We would like to know if he is deemed top pose a particular risk to a particular demographic .

We know that he appears to fixate usually on and target single females living locally ,Krystal Davies ( formerly of 25 Shrub House who says she moved because of him) and now Dawn Mackender at #20 Shrub House who he has been abusive towards which cause Police attendance last summer ( not taking in to account his weed smoking and fire burning which cause her respiratory issues).

Regards other and future tenants, we have a constant turn over of new residents, and we would look to be mindful of whether we can reduce risk for any group of persons moving in to Shrub house Close, which will happen at some stage soon. The residents in Shrub House Close are mostly but not exclusively approaching or in 'middle age' and I believe there may be children in some private residences locally

The recent threats and references he made towards myself and others leading to the criminal and civil court cases has posed other questions about staff visits to the address and the safety of staff making those visits and what measures FHG should instigate to ensure staff safety .

The questions we would seek to know to help us put the correct measures in place revolves around ....'Does MBD pose a particular risk to a particular demographic?'.....if he were being currently supervised by the PPU this would indicate he does and then we could apply for more relevant detail unless the area he's being supervised for can be indicated ....especially if it touches on the demographic Ive described .

Morning Karl ,

Moving on with this .....as you are aware we have a civil action on going in relation to MBD and we had a meeting about this and the next steps this morning .....

One of the aspects was 'other tenant ' safety and staff safety and how to approach visits as well as how to address matters such as potential MH concerns in with this .

Here I would add in that just before X-mas I had a meeting with 2 MH workers from NSFT who had requested the meeting after a source had expressed concerns about MBD's MH .

During that conversation one of the two MH workers recalled MBD from when he lived in Red Lodge some years ago and how he was reportedly 'run out of town' because of alleged paedophile type behaviour .

I am also aware from his own admissions and information that he consorts with prostitutes and has in the past taken in a young woman who he described as a 'fallen ' daughter of an old army friend . I believe she eventually made an allegation of sexual assault against him .

So the question I have been tasked to ask is delicate and it is ..... 'Is MBD currently open or subject to any Public protection unit case /attention /supervision at this time ?

If you are unable to confirm or otherwise could you give me details of somebody in that unit I could try and contact .

Dear Mr Burdette Deakin

We are writing to you about your recent conduct towards our staff, we note this is not the first time we have had to write to you regarding these issues and it's not something we are willing to tolerate.

An issue was reported regarding yourself having bonfires and smoking cannabis in your property, since we made you aware of the complaints we are receiving, you have continually emailed Pete Sharples multiple times in a day using unacceptable language. At the peak, these emails are being sent hourly by yourself to Pete.

We understand this is frustrating and you have claimed that the cannabis is for medicinal use, however we have a duty to investigate any behaviour complaints that are received and will continue to do so until the problem is resolved.

We will not tolerate, under any circumstance, abuse, aggression or threatening behaviour towards members of our staff or contractors. You are currently not permitted to attend any of Flagships Offices in person, and if the behaviour continues by email, we will have no option but to restrict the communication we have with yourself in the future by this means also.

Should you engage in any further anti-social behaviour towards our staff, in breach of your tenancy, then we shall consider taking formal tenancy action against you, which may result in possession proceedings. This letter, along with the previous letter sent to you regarding your conduct will remain on your house file.

As you have been advised in the past, if you wish to raise any tenancy queries or make contact with a member of staff at Flagship you must do so over the telephone via our Response centre. We would

also like to make you aware that abusive or threatening behaviour will not be tolerated over the telephone, likewise it will not be tolerated by email.
