

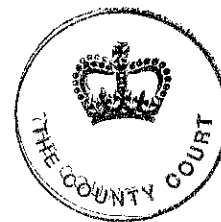

Notes for guidance

- The claim form and the particulars of claim, if served separately, must be served on the defendant within 4 months of the date of issue (6 months if you are serving outside England and Wales). You may be able to apply to extend the time for serving the claim form but the application must generally be made before the 4 month or 6 month period expires.
 - You must inform the court immediately if your claim is settled or discontinued.
- The defendant may**
- admit the truth of the whole or any part of your claim.** The court will send you a copy of the defendant's admission and tell you what to do next.
 - file an acknowledge of service.** This will allow the defendant 28 days from the date of service of your particulars of claim to file a defence or contest the court's jurisdiction.
 - dispute the whole claim.** The court will send you a copy of the defence.
 - not reply at all.** You may make an application to the court for judgment. A fee may be payable.

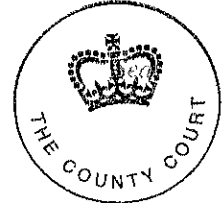

Deputy District Judge Stevens sitting at the County Court at Norwich, The Law Courts, Bishopgate, Norwich, Norfolk, NR3 1UR.

The Court ordered that Mr Michael Burdette-Deakin

is forbidden (whether by himself or by instructing or encouraging or permitting any other person) from:

1 a) Causing harassment, alarm or distress to any other current or former resident of Shrub House Close or any member of staff and/or contractor employed or working on behalf of the Claimant, including but not limited to:

i) Using any threatening words or behaviour by any form of contact whether that be in person, telephone, emails or derogatory words over social media etc.

ii) Using any form of contact excessively to these individuals.

iii) Not to interfere with the Claimant's Housing Management functions whether that be intentionally or as a result of an Anti-Social Behaviour act you have carried out or anyone you have instructed to carry out such an act

iv) Not to contact the Claimant or any staff or contractors of the claimant except in circumstances where there is a genuine housing need.

v) Using any form of illegal drugs at 22 Shrub House Close, Beck Row, Bury St Edmunds, IP28 8AN

b) From acting in a manner likely to cause a serious risk of harm to any current or former resident of Shrub House Close or any member of staff and/or contractor employed or working on behalf of the Claimant.

c) From attending any of the Claimants registered offices in person without an appointment

Power of Arrest

And the judge finding:

That the conditions in section 9 of the Anti-Social Behaviour, Crime and Policing Act 2014 are satisfied,

And the court being satisfied that:

That the conduct consists of or includes use or threatened use of violence and there is significant risk of harm to a person towards whom the conduct prohibited by this Injunction is directed.

This Power of Arrest was ordered on 14 October 2020 and expires on 14 October 2021.

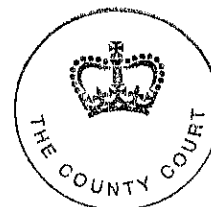

The Court Ordered that Mr Michael Burdette-Deakin

is forbidden (whether by himself or by instructing or encouraging or permitting any other person): from:

i) Using any threatening words or behaviour by any form of contact whether that be in person, telephone emails or derogatory words over social media etc.

ii) Using any form of contact excessively to these individuals.

iii) Not to interfere with the Claimant's Housing Management functions whether that be intentionally or as a result of an Anti-Social Behaviour act you have carried out or anyone you have instructed to carry out such an act.

iv) Not to contact the claimant or any staff or contractors of the claimant except in circumstances where there is a genuine housing need.

v) Using any form of illegal drugs at 22 Shrub House close, Beck Row, Bury St Edmunds, IP28 8AN.

b) From acting in a manner likely to cause a serious risk of harm to any current or former resident of Shrub House Close or any member of staff and/or contractor employed or working on behalf of the Claimant.

c) From attending any of the Claimants registered offices in person without an appointment.

This order shall remain in force until 14 October 2021 at 4:00 PM unless before then it is revoked by further order of the court

The Defendant shall have liberty to apply on 48 hours' notice to vary or discharge this Order without waiting for the return date.

The Court is satisfied that the contact which is prohibited by this Injunction consists of or includes the use or threatened use of violence and there is significant risk of harm to a person towards whom the conduct prohibited by this Injunction is directed.

A Power of Arrest is attached to all terms of the Injunction whereby a Constable may under the Power given in Section 9 of the Anti-Social Behaviour, Crime and Policing Act 2014 arrest without Warrant the Defendant if the Constable has reasonable cause for suspecting that the Defendant is in breach of the terms of this Injunction Order.

Following the National Guidance that, in light of the exceptional circumstances of the current national public health emergency, hearings should be conducted remotely, either by email, telephone, video or Skype and that attendance at court should only be in urgent and exceptional circumstances and where it is safe to do so;

BY THE COURT'S OWN MOTION IT IS ORDERED:

1. The hearing that is listed in this matter on **6 November 2020** shall take place by way of remote hearing pursuant to CPR 3.1 (2) (d) unless the court directs otherwise.
2. The hearing will be conducted by telephone using BT Meet Me.
3. The court will telephone you and any others who are to attend the hearing on the contact number(s) you provide when the hearing is ready to begin.
4. To prepare for the hearing you must:
 - (a) Ensure that your documents and witness statements are filed with the court and served upon the other party in accordance with any orders made previously or any applicable Rule or Practice Direction; and
 - (b) By no later than 21 days before the hearing:
 - (i) provide to the court and to the other party the names and contact telephone numbers for all those who are to attend the telephone hearing. This should include the contact telephone numbers for all legal representatives, parties and witnesses. The contact number(s) must be direct dial numbers (not switchboard numbers) and must be numbers that will not be used by others at the time scheduled for the hearing.
 - (ii) confirm to the court if you need an interpreter, or other support to join the telephone hearing.
 - (iii) if you cannot join the telephone hearing contact the court to explain why not. This may be considered by the judge
 - (c) Ensure that all those who are to attend the telephone hearing are available to be contacted on their contact telephone number at the scheduled start time for the hearing (and thereafter as it is not always possible to start the case at the scheduled time)
5. If a party fails to provide contact telephone numbers in accordance with this order the Judge may decide the case in the absence of that party based on the evidence available to him/her.

6. If one of the parties is legally represented, the legal representative for that party must by no later than 48 hours prior to the hearing electronically file a PDF bundle with the court which must include:

- (a) A case summary;
- (b) The parties' position statements;
- (c) The previous orders that are relevant to the remote hearing;
- (d) All essential documents to determine the issues that fall for determination at the remote hearing;
- (e) A draft order.

7. If both parties are legally represented it shall be the responsibility of the claimant's solicitors to provide the electronic bundle to the court in compliance with paragraph 6 of this order.

8. Because this Order has been made without a hearing, the parties have the right to apply to have the order set aside, varied or stayed. A party making such an application must send or deliver the application to the court (together with any appropriate fee) to arrive within seven days of service of this Order.

IMPORTANT NOTES REGARDING BT MEETME:

As part of our response to Coronavirus, this hearing will now take place by telephone and you should not attend the court centre

- It's important you're ready to accept the call at the time of the hearing so that you can take part
- If you do not answer the call, the hearing may go ahead, and a decision could be made in your absence
