Good Morning Mr Burdette-Deakin,

As you will be aware from our letters of the 26th April 2023 and 5th May 2023 our file of papers is now closed having terminated our retainer with you.

As set out in our letter of the 26<sup>th</sup> April 2023 you are of course still entitled to pursue this claim via alternate solicitors if you wish provided you ensure you do so within the set limitation periods which I outline below for you again for completeness.

*"Please note that you have a 3-year limitation period to bring any claim for injury and a 6-year limitation period for any unlawful arrest/detainment/false imprisonment or trespass to your property. These periods are from the date of your arrest so the most impending deadline is that of injury (including psychological injury) and will expire on the 26th September 2023, leaving you at that stage unable to pursue any injury aspect of your claim against Suffolk Constabulary arising from your arrest on the 27th September 2020."*

We will not be engaging in any further communication in this matter moving forwards.
