

# 2017–2018 ASB Data Bridge Contamination Chain

Origin, Escalation, and Downstream Contamination Across Police, Housing, and Clinical Agencies

---

## 1. Overview

This page documents the earliest confirmed contamination vector within the continuum: the sequence beginning with the **2017 assault (37/68425/17)**, followed by the **17/07/2018 assault and false “paedophile” allegation**, the related **13/08/2018 CAD record**, and the **21/08/2018 ASB letter**. These events collectively show:

- Police failures to create required crime reports
- ASB reversal of victim/perpetrator roles
- Early narrative distortion that later fed into:
  - SNT records
  - Sharples’ statements
  - Bunn’s 2022 committal evidence
  - Mental-health misclassification (2020–2021)
  - Downstream contamination in 2022–2025

This chain is foundational to understanding how the later ASB-driven narrative (“fixated,” “dangerous,” “delusional,” “harassing,” “persistent”) developed despite contradictory evidence.

## 2. Primary Events in the Chain

### 2.1 20/10/2017 — Assault (Crime Ref: 37/68425/17)

The earliest documented incident. The Victim was assaulted in Holmsey Green. Police recorded a crime for:

- **Common Assault**
- **Section 4 Public Order**

The investigation was later closed for claimed “insufficient evidence,” but this reference resurfaces repeatedly in later, contaminated accounts.

### 2.2 17/07/2018 — Physical Assault + Defamatory Allegation (“paedophile”)

The Victim was *physically assaulted* returning from the local shop. Immediately before the assault, a male exited Shrub House Close, shouted out of his vehicle “watch that man down there, he’s a paedophile,” and sped away. Moments later, the Victim was assaulted.

Ambulance records confirm:

- dragging injuries
- knee swelling
- numbness and reduced sensation
- multiple officers and ambulance crew on scene

Police did **not** create a crime report, despite mandatory requirement due to:

- injury
- defamation
- public order behaviour
- repeat victimisation

### 2.3 13/08/2018 — CAD SC-13082018-247

This CAD record **explicitly links the July 2018 assault to the earlier 2017 crime (37/68425/17)**, confirming police:

- were aware the Victim was assaulted
- knew the identity/location of the individuals involved
- still failed to create a separate crime report
- allowed the incident to “float” unrecorded

This omission directly enabled later ASB reframing of the Victim as the “source of issues” in Shrub House Close.

### 2.4 21/08/2018 — ASB Officer Letter (Sharples)

Rather than address the assault, the ASB Officer issued a letter reframing the Victim as:

- a perpetrator of harassment
- a maker of unfounded allegations
- responsible for neighbourhood tension

This letter becomes the **first written codification** of the ASB narrative that will later contaminate:

- mental-health assessments (2020, 2021)
- SNT briefings
- Bunn’s committal statement (2022)
- CAD characterisations
- court proceedings

## 3. Structural Impact

The failure to record the 2018 assault and the ASB re-framing of events created a contaminated “origin story” that became:

- the basis for misinterpretation of Victim’s safeguarding concerns
- input to the Professionals’ Meeting (2021)
- the justification for malicious allegations
- material relied upon by Sharples and Bunn in later statements
- the backbone of the policing narrative 2020–2022

This chain ultimately fed into the **tainted Statement of Truth** that led to the Victim’s wrongful committal.

## 5. Conclusion

The 2017–2018 ASB Contamination Chain is the earliest demonstrable systemic failure within the continuum. It shows police non-recording of crime, ASB reversal of victim-perpetrator roles, and the creation of false behavioural narratives that were later recycled into clinical assessments, CAD logs, landlord briefings, witness statements and ultimately, committal proceedings.
