

# Fraud Continuum – Causal Chains (Chronology Anchors)

## Chain 1 – 2009-2014: Precedent Fraud Anchor

- Ex-Wife/Family Court matter (police arrests/unlawful DLA deduction attempt, confirmed by KC Bryant).

## Chain 2 – 20/10/2017: Assault → Sharples Bias

- Assault logged.
- ASB Officer Sharples intervenes, framing you as aggressor.
- Becomes seed distortion infecting landlord and police records.

## Chain 3 – 17/07/2018: Assault → 13/08/2018 CAD Falsification → PSD (2025)

- EEAS: assault + paramedic attendance.
- Police CAD/Crime Ref mis-logged as “criminal damage.”
- PSD in 2025 still rely on the falsified CAD.
- *Seed fraud in official record base.*

## Chain 4 – 30/08/2018: ASB Officer Letter → Narrative Suppression

- Landlord/ASB letter reframes you as harasser despite being victim of assaults.
- Used later in injunction bundle.
- *Narrative control → feeds civil process misuse.*

## Chain 5 – 18/02/2021: Statement of Truth → Entrenchment

- Falsehoods (criminal damage, behaviour allegations) sworn into court record.
- *Formalisation of falsification → prepares ground for committal risk.*

## Chain 6 – 27/09/2020: Arrest → N16A Injunction → N205C Committal

- Arrest event.
- Injunction (N16A) and committal (N205C) pursued on falsified base.
- Victim, as LiP, lawfully challenged injunction → treated as contempt.
- *Civil procedure weaponised.*

## Chain 7 – 2019–21 Zapata Reports → 16/11/2022 Singh Report → Satchell Moran Withdrawal

- Zapata introduces psychiatric distortion (Sharples input).
- Singh repeats Zapata as NHS authority.
- When challenged, Satchell Moran withdraws from NWNF police claim.
- *Professional abdication → failure of legal safety net.*

## Chain 8 – 01/07/2025 EEAS Disclosure → 06/09/2025 HNK Rediscovery → Tainted Files in Current Proceedings

- EEAS disclosure confirms paramedic attendance at 17/07/2018 assault, proving Suffolk Constabulary record falsification.
- PSD correspondence in September–October 2025 still relies on the falsified CAD, confirming live institutional error.
- Rediscovery shows Singh report and contaminated records passed into HNK files. Fraud continuum remains live in present litigation.
- *Fraud continuum remains live in present litigation.*

### ✓ Continuum Summary for Counsel

- **Origin:** 2017 Sharples bias + 2018 falsification.
- **Entrenchment:** 2018 ASB suppression, 2021 sworn statements.
- **Civil Misuse:** 2020 arrest → injunction/committal.
- **Professional Amplification/Abdication:** Zapata → Singh → Satchell Moran.

- **Present Day:** 2025 rediscovery proving contamination still active.

This demonstrates the **continuum is multi-strand and persistent**. The 13/10/2022 committal cannot be carved out as “criminal” because every strand feeding it is rooted in civil fraud and misfeasance.
