

1. Jurisdictional Defect – N205c vs Alleged Hearing

- **Fact:** N205c dated **14 Oct 2020** proves issue of proceedings post-dates the alleged **16 Sept 2020 hearing**.
 - **Effect:** Court had **no jurisdiction** on 27 Sept 2020 (arrest date) or 16 Sept 2020 (claimed hearing).
 - **Exculpatory vector:** unlawful arrest / false imprisonment; abuse of process; malicious prosecution; misfeasance in public office.

2. False Statutory Declaration on N16A

- **Fact:** Applicant declared “No” to Human Rights Act relevance.
 - **Effect:** False representation in a verified statement → *Perjury Act 1911 s.5 / Fraud Act 2006 s.2* breach.
 - **Exculpatory vector:** vitiates injunction and all derivative orders; demonstrates malice and knowledge of falsity.

3. Service Defect and Breach of CPR 23.7 / 25.3

- **Fact:** Application (9 Oct 2020) and issue (14 Oct 2020) not served until **4 Nov 2020**.
 - **Effect:** Fails mandatory 3-day notice rule → order obtained without jurisdiction.
 - **Exculpatory vector:** nullity of process; denial of natural justice; voids enforcement actions (arrest, committal, imprisonment).

4. False Accompanying Letter (02-11-2020)

- **Fact:** Letter claimed a “final order and power of arrest” existed from **16 Sept 2020**.
 - **Effect:** Demonstrates **deliberate misrepresentation** of a non-existent court outcome.
 - **Exculpatory vector:** proves knowing fraud by claimant and reliance by police; supports aggravated/exemplary damages.

5. Police and Institutional Reliance on Void Process

- **Fact:** Arrest (27 Sept 2020) executed on claim of “power of arrest” before any process existed.
 - **Effect:** Police action **ultra vires**; constitutes unlawful deprivation of liberty.
 - **Exculpatory vector:** false imprisonment; misfeasance; breach of Articles 5, 6, 8 ECHR.

6. Fraud Unravels All

- **Fact:** Repeated false representations and concealment reset limitation clock.
 - **Effect:** *fraus omnia corrumpit* applies — injunction and subsequent contempt/imprisonment void ab initio.
 - **Exculpatory vector:** resets limitation periods; grounds for damages and declaration of nullity.
